

- **Sec. 11:415. - Stopping, standing or parking prohibited; general rules.**

- (a) No person shall stop, stand or park a vehicle, or permit a vehicle registered in his name to be stopped, standing or parked, except when necessary to avoid conflict with other traffic or in compliance with law or the directions of a law enforcement officer or traffic-control device, or parking-control device in any of the following places:
 - (1) On a sidewalk;
 - (2) In front of or blocking a public or private driveway;
 - (3) Within an intersection;
 - (4) Within fifteen (15) feet of a fire hydrant;
 - (6) Within twenty-five (25) feet of a crosswalk or **curbline** at an intersection;
 - (7) Within thirty (30) feet upon the approach to any flashing beacon, stop sign, or traffic-control signal located at the side of a roadway;
 - (12) On the roadway side of any vehicle stopped or parked at the edge or curb of a street;
 - (15) On the driver's left-hand side of any two-way street or highway;
 - (19) Any place where parking will obscure or obstruct visibility of any traffic-control device;
 - (22) On the grass in the front yard between the front of the residence and the street of any lot in the A1, A2, A2.5, A3 or A4 districts and in recognized subdivisions in the rural district.
- (b) No person shall move a vehicle not lawfully under his control into any such prohibited area or away from a curb such distance as is unlawful.

- **Sec. 11:416 - Parking on neutral ground, parks, rights-of-way, sidewalks and other public and private places prohibited.**

- (a) No person shall stop, stand or park a vehicle or permit a vehicle registered in his name to be stopped, standing or parked, except when necessary to avoid conflict with other traffic or in compliance with the law and directions of a police officer or traffic parking-control device, at any of the following places:
 - (1) Upon a neutral ground, right-of-way, sidewalk, strip of land between a property line and street curb, or other public way.
 - (4) Upon privately owned property without the prior authorization and consent of the owner thereof.

- **Sec. 11:421. - Parking not to obstruct traffic.**

No person shall stand or park any vehicle or permit any vehicle registered in his name to be standing or parked upon a street, highway or within an alley in such a manner or under such conditions as to leave available less than ten (10) feet of the width of the street, highway or alleyway for free movement of vehicular traffic or blocking the driveway entrance to any abutting property.

- **Sec. 11:423. - Time limitation on parking on any street.**

No person shall permit his vehicle, either as an operator or registered owner, to remain parked on any street for a period of time longer than nine (9) hours of any twenty-four-hour period beginning at 6:00 a.m., of one day to 6:00 a.m., of the next day, and the vehicle can only be so parked if parking is specifically permitted under other provisions of this title.

Title 14 – ANIMALS

CHAPTER 2. - KEEPING OF DOMESTICATED ANIMALS

- **Sec. 14:204. - Owner's responsibility.**

- (a) *Threats to public health and safety.* The owner or possessor of any dog shall be held responsible and liable for any and all actions taken by said dog, including but not limited to:
 - (1) Confining his dog in such a manner so as to prevent escape. All dogs shall be kept, at all times, from running at large.
- (b) *Other provisions.* The owner or possessor of any dog or cat shall be held responsible and liable for any and all actions taken by said dog or cat, except community cats, including but not limited to ensuring that:
 - (1) All cats shall be kept, at all times, from running at large.
 - (3) No dog or cat shall cause a nuisance. The owner or possessor of a dog or cat shall be held responsible for any behavior of the dog or cat that is deemed a nuisance.
 - (5) No dog shall cause any excessive noise making or excessive barking. The animal control and rescue center will respond to excessive noise making and excessive barking dog complaints in the following manner:

- **Sec. 14:208. - Potentially dangerous dog, dangerous dog, vicious dog.**

- (a) ***Level 1—Potentially dangerous dog:***

- (1) A dog may be classified as "potentially dangerous" if such dog constitutes a menace to public health or safety. In order for a dog to be classified as "potentially dangerous," one (1) of the following incidents shall occur:
 - d. A dog which on two (2) separate occasions within a twelve-month period has been observed at large, on or off the owner's property, or has been impounded at least one (1) prior occasion for being at large.
- (4) The owner of a dog that has been classified as "potentially dangerous" shall take whatever measures are necessary to confine or restrain such animal to prevent any future incidents from occurring that constitute a menace to public health or safety.

Title 13 - CRIMINAL LAW

Sec. 13:1056. - Curfew for Juveniles

- **Sec. 13:1056.2. - Offenses.**

- (a) A juvenile may not remain in a public place or on the premises of an establishment between the hours of 11:00 p.m. and 5:00 a.m., except on Friday and Saturday nights, when the hours shall begin at 1:00 a.m. and end at 5:00 a.m.
- (b) A custodian may not permit or by insufficient control allow a juvenile under the custodian's care or custody to violate this section.
